# **Snapshot: Gender-Sensitive Public Procurement Survey**

#### **GATHERING DATA**

The UK commissioned a study to understand the use of gender sensitive public procurement in international entities.



#### Overview

Major international entities (multilaterals, bilaterals and non-profits, working in international development or similar sectors) use various models to implement **gender-sensitive (public) procurement** (GSPP<sup>I</sup>) in their own operations. The former Department for International Development (DflD) in the UK commissioned a 10-day study of 40 organizations to explore these models. The study, issued on June 22, 2018, reported:

"Few international entities working in international development, humanitarian aid, or similar sectors, are systematically implementing GSPP in their own operations, a rapid survey of 40 such multilateral, bilateral and non-profit organizations conducted for this report shows. ... a dearth of information on GSPP that was publicly and easily available from these actors. Even data from the email survey is limited, self-reported, and often preliminary."<sup>2</sup>

UN Women	Yes	Full though recent implementation across UN Women, focus on women-owned businesses, though some attention to other models (e.g., suppliers' gender balance in workforce or gender equality policies)
